- Resolution 23-070: Authorization to Execute a Memorandum of Understanding (MOU) 106
- to Evaluate the Effectiveness of Carp Management as a Watershed Management Strategy 107
- in Partnership with the MPCA and DNR 108

Mr. Brian Beck appeared before the Board of Managers to review the request for board action. He explained that this collaboration with the Department of Natural Resources and the Minnesota Pollution Control Agency grew out of MCWD's experience with carp management for the Six Mile Creek Halsted's Bay habitat restoration project. These discussions have highlighted the need to better understand the impact of carp management on vegetation conditions and water quality, given that no comprehensive assessment has been conducted on the numerous carp management projects that have been implemented throughout the state of Minnesota in the past 10 years. District, DNR, and MPCA staff have discussed each agency's interest in evaluating MCWD's carp management data set, along with other statewide data, to continue to refine their understanding of these issues.

It was moved by Manager Miller, seconded by Manager Maxwell to adopt Resolution 23-070: Authorization to Execute a Memorandum of Understanding (MOU) to Evaluate the Effectiveness of Carp Management as a Watershed Management Strategy in Partnership with the MPCA and DNR as follows:

NOW, THEREFORE, BE IT RESOLVED that the Minnehaha Creek Watershed District Board of Managers hereby authorizes the Administrator to execute the Memorandum of Understanding among MCWD, DNR, and MPCA.

 In response to a question from Manager Hejmadi, Mr. Beck stated that he expected this initial phase of collaboration would take about one year. Manager Sando asked about the nature of MCWD's financial commitment, and Mr. Beck explained the \$75,000 commitment from MCWD was originally budgeted for MCWD's internal evaluation purposes but would now have potential statewide application. In response to a question from Manager Olson, Mr. Beck traced the DNR and MPCA interest in these issues. Manager Loftus asked Mr. Smith about the legal nature of the Memorandum of Understanding, and he contrasted the MOU with the binding promises expressed in a cooperative agreement. Manager Hejmadi asked if the two state agencies have committed expertise and enthusiasm to this undertaking to match the commitment from MCWD. Mr. Beck reviewed the interest and participation to date. *Upon vote, the motion carried 7-0.*

STAFF UPDATES

154 Administrator's Report

Mr. Wisker reported on the following items:

1. Mr. Wisker reported that annual precipitation year to date is about two inches below normal. The Gray's Bay Dam has been closed since July. Lake Minnetonka is at 928.6 feet, the runout elevation. Minnehaha Creek is flowing at 20 cubic feet per second at Hiawatha.

2. As noted by President White, recent meetings with Hennepin County Commissioners Anderson and Lunde were cordial and productive. President White, Manager Hejmadi and Mr. Wisker have a meeting scheduled next Monday with Commissioner Conley.

3. With assistance from Manager Olson, staff have held productive conversations with Lennar about planned development in west Victoria. The conversations indicate a potential collaboration to enhance greenway connections and integrating natural resource protection with development plans.

4. This week marks the 15th anniversary of Becky Christopher's service to the MCWD. Her service with permitting, rules revision, planning, and the shift for the capital improvement program to include the Land and Water Partnership program reflect major contributions to the work of the District. Her work with the budget, compensation plan, Climate Action Framework and the Diversity, Equity and Inclusion Framework are also major contributions. The managers thanked Ms. Christopher for her 15 years of service.
