Recommended action: Appoint the 2024 MCWD Citizens Advisory Committee

Summary:

At the <u>November 9, 2023</u> Operations and Programs Committee (OPC) meeting, staff facilitated dialogue with the Board of Managers on the 2024 Citizens Advisory Committee (CAC) applicant pool. Since that time, staff have prepared recommendations to support the appointment of the 2024 CAC.

Background:

According to MN Statute §103D.331, the Minnehaha Creek Watershed District (MCWD or District) Board of Managers must annually appoint an Advisory Committee. On June 10, 2021, the Board approved Resolution 21-042 adopting operational recommendations to align the CAC with the strategic direction of the District and advance its Balanced Urban Ecology policy. These recommendations included setting the size of the CAC at fourteen members and instituting staggered, two-year terms for CAC members. CAC recruitment and appointment processes are structured according to these operational recommendations.

2024 Recruitment and Application Process:

Recruitment of members was supported through a variety of promotional strategies from September 6, 2023, to the application deadline of October 16, 2023. Current CAC members were encouraged to re-apply, and new applicants were solicited to participate in a competitive application process to determine CAC appointments at the discretion of the Board of Managers.

Following the deadline for CAC applications, MCWD Outreach staff briefed the OPC on November 9, 2023 on the 2024 appointment process, key considerations, and provided a preliminary staff assessment of the 12 applications received for the eight open spots on the 2024 CAC. Five current CAC members expressed interest in returning and seven applications were received from District residents interested in joining the CAC.

2024 CAC Appointment Recommendations:

Discussion and feedback generated by the committee guided staff in developing the recommendations outlined in this request for Board action, summarized below:

- Appoint current members who are continuing the second year of their term in 2024.
- Appoint five interested incumbent members to a two-year term from 2024-2025.
- Appoint three new candidates to a two-year term from 2024-2025.

Based on the considerations outlined above and discussed by Committee, staff recommends the appointment of 14 CAC members to the 2024 CAC.

WHEREAS	pursuant to MN statute §103D.331, the Minnehaha Creek Watershed District (MCWD) Board of Managers annually appoints a Citizen Advisory Committee (CAC), to assist the Board of Managers on matters affecting the interests of the watershed district; and
WHEREAS	on June, 10, 2021, the Board approved Resolution 21-042 adopting operational recommendations to align its CAC with the overall strategic direction of the District; and
WHEREAS	recommendations included introducing two-year, staggered terms; setting CAC membership at fourteen; and striving for greater diversity of professional, geographic, and demographic make-up of members; and
WHEREAS	MCWD Outreach staff undertook several enhancements to the CAC member recruitment process and

received twelve applications for eight vacancies on the 2024 CAC (five from current members and

seven from new applicants); and

WHEREAS the Board of Manager's Operations and Programs Committee discussed the applications at their

November 9, 2023, meeting to provide staff feedback on developing a slate of 14 candidates for 2024

appointment; and

staff prepared a recommendation for appointment at the December 14, 2023, meeting. **WHEREAS**
