Summary:

The Minnehaha Creek Watershed District (MCWD) is responsible to inspect and maintain 26 stormwater ponds through ownership or cooperative agreements with its partner communities. The MCWD Board of Managers established a policy that guides the investigation and maintenance of its stormwater management infrastructure to ensure the long-term water quality and water quantity function of these systems.

In 2023 the MCWD completed the Stormwater Pond Data Analysis. A 20-year schedule was developed, and ponds are now selected for survey and maintenance based on historical data and a calculated sedimentation rate for each pond. This maintenance is necessary to ensure stormwater ponds are functioning as designed and continue to accrue their designed water resource benefit.

In 2023 Twin Lakes Park Pond and Nokomis-Amelia Pond were identified for need of dredging maintenance. This maintenance project was slated for the winter of 2023-2024 but was delayed and ultimately cancelled following unseasonably warm temps and additional permitting hurdles encountered at the Nokomis-Amelia Pond.

Stantec was contracted to separate and update plans and specifications from the 2023-2024 package, provide bid documents and support, and conduct construction administration and observation for winter 2025-2026 maintenance dredging of Twin Lakes Park Pond.

Bid Selection:

Following Board approval of plans, the bid package was posted to an online platform, QuestCDN, September 26, 2025. Open bid window was two and half weeks with a mandatory pre-bid meeting held onsite on October 6, 2025. Bids were opened the morning of October 15, 2025. Eight firms submitted bids with the apparent low bid from Frattalone Companies. Following review, Stantec and District staff find the bid to be responsive and find Frattalone to be a responsible bidder.

The Engineers' opinion of probable cost was \$368,885, compared to this Frattalone's bid is favorable. Full bid tabulation has been distributed separately to the Board of Manager, via email, in accordance with Minnesota Statutes §13.591.

Recommendation:

At the October 23, 2025 Board meeting, staff recommends Frattalone Companies be awarded the contract in the amount of \$254,580 for maintenance of the Twin Lakes Park Pond, and that the Board authorize the District Administrator to issue change orders totaling up to 10% of the contract price.

WHEREAS, Minnehaha Creek Watershed District (MCWD) engages in regional capital improvement projects as

described in its Water Resources Management Plan;

WHEREAS, MCWD has a policy that guides the investigation and maintenance of its stormwater management

infrastructure and conducts pond sediment surveys on the 26 regional ponds that MCWD is responsible

to inspect and maintain;

WHEREAS, the Project Maintenance and Land Management Program (PMLM) annually budgets for this effort in

accordance with Stormwater Pond Maintenance Capital Projects budget;

WHEREAS, utilizing MCWD's Stormwater Pond Data Analysis, in 2023, the Board of Managers ("Board") identified

Twin Lakes Park pond and Nokomis-Amelia pond for Winter 2023-24 maintenance;

WHEREAS, maintenance work for the winter of 2023-2024 was designed and contracted but unseasonably warm

weather and additional permitting hurdles specifically for the Nokomis-Amelia pond work, due to presence of Blanding's turtles, delayed work and ultimately led to the termination of the construction

contract in November 2024;

WHEREAS, on August 14, 2025, the Board authorized a new contract with Stantec to separate design and

specifications for Twin Lakes Park Pond, provide bid documents and support, and conduct construction

administration and observation;

WHEREAS, on September 25, 2025, the Board reviewed a final design project manual and opinion of probable cost

for maintenance dredging of Twin Lakes Park Pond;

WHEREAS, on September 26, 2025 Staff release the project bid package to an online platform, QuestCDN. A

mandatory pre-bid meeting was held at the project location October 6, 2025;

WHEREAS, on October 15, 2025 eight bids were opened, and Frattalone Companies submitted the low bid;

WHEREAS, Stantec, as project engineer, and Staff find Frattalone Companies bid to be responsive and consider

Frattalone Companies to be a responsible bidder; and

WHEREAS, The Board concurs with staff and project engineer, and adopts their findings;

NOW, THEREFORE, BE IT RESOLVED that the Minnehaha Creek Watershed District Board of Managers awards the

contract for maintenance of Twin Lakes Pond to Frattalone Companies in the amount of \$254,580;

BE IT FURTHER RESOLVED that the District Administrator is authorized, on advise of counsel, to enter into a contract with Frattalone Companies for the stated contract price, and further is authorized to execute change orders in his discretion up to an additional 10%, in aggregate, of the contract price; and
