### **PURPOSE or ACTION REQUESTED:**

Board approval of the annually revised Capital Improvement Plan (CIP)

### PAST BOARD ACTIONS:

- April 26, 2017 Planning and Policy Committee review of draft CIP
- May 25, 2017 Res. 17-039: Authorization to distribute draft CIP for 30-day comment

#### SUMMARY:

At the May 25, 2017 Board Meeting, the Board reviewed the annually revised draft Capital Improvement Plan (see attached) and authorized its distribution to the cities and counties for 30 day review and comment.

This annual CIP includes projects that are currently in development and have an estimated schedule and budget. The draft Watershed Management Plan (Plan) that is currently out for review contains a 10-year CIP that includes a broader list of potential projects throughout the watershed, many of which are opportunity-driven to allow the District to respond to land use change and partnership opportunities that arise during the 10-year plan cycle. Cities, counties, and other partners are encouraged to approach the District with project opportunities that may then be incorporated into the District's annual CIP or considered for cost share grants based on timing, alignment with District goals, and available funding.

The annual CIP identifies potential funding sources for the projects as well as the estimated breakdown of District and outside costs. The estimated MCWD costs listed do not represent actual budget projections for these years as they do not account for projects that are levied over multiple years or financed through the counties or project partners.

Comments on the draft CIP were accepted from June 16, 2017 to July 17, 2017. Staff received responses from six cities, all of which are attached for Board review. These include letters of support from the cities of Mound, Hopkins, and Minnetrista. A letter was also received from the City of Greenwood expressing concerns about potential levy impacts and requesting that the District reduce the proposed CIP. The District Administrator and a few of the Board Members will be meeting with the Greenwood Mayor and Council Members this week to discuss their concerns.

A comment letter was also received from City of Minneapolis expressing support for the District's Plan and current partnership with the City to align planning and capital improvements within the Minneapolis section of Minnehaha Creek. The letter requests that, as the District and City work to develop a plan and funding strategy for the Fulton Neighborhood Flood Project, the District consider adding the it to the CIP.

Finally, staff received an email from staff at the City of Plymouth, sharing the City's 5-year CIP and expressing interest in exploring partnership opportunities. Staff will arrange a meeting with City staff to discuss the proposed projects and potential for District involvement.

Staff has considered the feedback received and recommends that the draft CIP be adopted with no further revisions. Staff will continue to coordinate with the cities of Minneapolis and Plymouth to explore the aforementioned project opportunities, and if advanced, these may be added to next year's CIP.

Dear Minnehaha Creek Watershed District Board of Managers,

The city of Greenwood received the MCWD's June 16, 2017 letter requesting comments regarding the MCWD's proposed Capital Improvement Plan. The letter stated the deadline for comment is July 17, 2017. The Greenwood city council discussed the topic at our July 5, 2017 meeting and concluded the following ...

The MCWD's 2017 Budget Fact Sheet shows a gap between \$13.46 million in spending and \$9.5 million in revenues. Given this large budget gap after a 7% levy increase in 2017, the city of Greenwood recommends that the MCWD reduce the scope of its CIP to help align its budget spending with its revenues without continued 7% range levy increases on properties in Greenwood and the rest of the watershed district.

Specifically we note the \$6.4+ million 2018 CIP includes \$2 million for the 325 Blake Road Demolition, \$1.5 million for the Arden Park Stream Restoration, and \$1.37 million for the Meadowbrook Golf Course Restoration. The city of Greenwood recognizes our taxpayers' obligation to support the mission of the watershed. However, given the MCWD's limited resources we request that the MCWD reduce the proposed CIP by closely examining the need for any discretionary projects and ensure that projects receive community support.

On March 17, 2017 I wrote to express support for the Minnehaha Creek Watershed District's (MCWD) Comprehensive Plan, which emphasizes geographically focused capital project implementation through collaboration and partnership with local communities. This approach makes sense, as it leverages partnerships and concentrates limited resources in areas of highest need and opportunity for measurable benefit.

The City is encouraged that the District is actively working, under a memorandum of understanding (MOU), in conjunction with the Minneapolis Park and Recreation Board (MPRB), to focus and align planning and capital improvements within the Minneapolis section of Minnehaha Creek. As you know, this portion of the watershed is one of the areas of highest need, with regards to addressing flooding, water quality, and ecological integrity.

Consistent with the MOU, the City, MCWD, and MPRB, are currently working to develop a set of shared capital improvement priorities that will produce a 2-5 year partnership plan and funding strategy. This plan will begin to outline project purpose and benefits, capital versus operational costs, funding strategies, timelines, and roles and responsibilities. Outlined in the MOU are three projects each respective agency is currently leading: FEMA flood damage repair, Hiawatha Golf Course, and flood mitigation area 29/30.

As the agencies develop the partnership plan and funding strategy, Minneapolis hopes to see phases of flood area 29/30 specifically identified in the MCWD draft CIP, with appropriate levels of funding, as this project remains a high priority for the City. The City anticipates having a consultant for the feasibility study of flood mitigation area 29/30 under contract by September 30, 2017, with implementable solutions to reduce flooding and improve water quality identified by March 2018. Our goal is to construct some flood mitigation work beginning in 2019 or 2020, in conjunction with road resurfacing south of 50<sup>th</sup> St. W. Any additional work identified in the feasibility study for the area north of 50<sup>th</sup> St. W would be constructed in 2021 or 2022 in conjunction with planned road reconstruction.

We appreciate MCWD's participation in the initial scoping conversations for flood area 29/30 and thank you for providing the opportunity to review the draft CIP. We are hopeful you will amend the draft to include the Fulton Neighborhood Flood project a.k.a. flood area 29/30 in the 2019 CIP and recognize that this project has the potential to act as the catalyst for a long and productive partnership between the City of Minneapolis, MPRB and MCWD.

As it does each year at this time, the Minnehaha Creek Watershed District (MCWD or District) is distributing its annually-revised Capital Improvement Plan (CIP) for your review and comment. Your input on the draft CIP is valuable in helping to identify new opportunities to work together to improve water resources.

This annually-revised CIP contains only those projects that are currently in development and have an estimated schedule and budget. The District is currently finalizing its draft Comprehensive Water Resources Management Plan (Plan) which will be distributed for review and comment in late June. The Plan will contain a 10-year CIP that will include a broader list of potential projects throughout the watershed. Many of these projects will be opportunity-driven to allow the District to respond to land use change and partnership opportunities that arise during the 10-year plan cycle. We encourage cities, counties, and other partners to approach the District with project opportunities that may then be incorporated into the District's annual CIP or considered for cost share grants based on timing, alignment with District goals, and available funding.

The annual CIP identifies potential funding sources for the projects as well as the estimated breakdown of District and outside costs. The estimated MCWD costs listed do not represent actual budget projections for these years as they do not account for projects that are levied over multiple years or financed through the counties or project partners.
