Summary:

The District has prioritized investment in information technology (IT) to enhance internal workflow and public interaction. This need was identified in the District's 2017 Strategic Alignment plan, which articulated the essential steps of eliminating disparate technology siloes and seeking solutions which efficiently move data across the organization. Investing in, and deploying, linked systems allows the District to make better informed data-driven decisions. In short, the District can more effectively pursue its strategic goals by eliminating technology silos and leveraging tools provided through connected IT systems.

The IT Update initiative began in earnest in July 2018 with the establishment of the cross-functional IT team. Through the work of that team, WSB was selected as the District's IT consultant to conduct discovery of organizational and program functional needs and present recommendations of budget, viable vendors and phasing. This Phase I work served as the plan for the current stage of the IT Update – evaluating, selecting and implementing connected IT systems.

Minnehaha Creek Watershed District's (MCWD) geographic information system (GIS) serves as the central platform connecting all subsequent systems implemented through the IT Update initiative, and will be the mechanism through which the data is shared and accessed across the organization. GIS provides tools for advanced analysis to increase understanding of the natural and built environments, and is a medium to enhance communication with external stakeholders and the public. GIS is the central hub of information for the District.

The Research and Monitoring (R&M) Department was scheduled to assess its IT needs after MCWD staff selected a GIS platform. In 2015, R&M invested in an establishing an industry standard commercial off the shelf (COTS) database system to store water quality, flow, and biological data (KISTERS WISKI database). WSB and R&M staff reviewed other potential database options and confirmed that the Kisters WISKI database was cost competitive and offered similar features as other databases. However, R&M staff identified that MCWD's Kisters license did not include the module to connect the WISKI database to GIS hub. Therefore, the only additional cost will be for an additional module to connect the WISKI database to MCWD's enterprise GIS system.

MCWD's current Kisters WISKI database license includes:

- Kisters WISKI User Licenses—Four user licenses for the Kisters WISKI database platform
- Kisters WISKI Annual Support and maintenance the core platform that supports the database
- Kisters WISKI (KiWQM) Water Quality Module Annual Support and Maintenance Module that supports the water quality database
- Kisters WISKI Biological Module (KiECO) Annual Support and Maintenance Module that supports the water quality database

MCWD's additional Kisters WISKI database license purchases include:

- *Kisters WISKI database connection module (KiWIS)* Module that supports GIS integration of R&M's water quality, hydrology, and biology data.
- Kisters WISKI KiWIS Annual Support and Maintenance Module annual support and maintenance.
- Kisters Training for KiWIS module Cost for training R&M staff on KiWIS module.

One year of maintenance was provided in the purchase price, which provides benefits such as software updates, training and technical support. The quote for maintenance, license renewal, and additional modules for Kisters WISKI is summarized in the table below:
