## **PURPOSE or ACTION REQUESTED:**

Final authorization is requested to enter into a contract with Applied Ecological Services for one year of vegetation maintenance at the Laketown Wetland Restoration, Six Mile Marsh Prairie Restoration, Long Lake Creek Wetland Restoration, and Methodist Hospital Wetland Restoration in the amount of \$29,365 and establish a not-to-exceed budget of \$32,302.

#### SUMMARY:

In 2003, the District adopted a policy in which the District maintains vegetation established as part of District projects. This action was in response to the finding that project partners may not have the expertise, budget, or oversight needed for ongoing vegetation maintenance and that the District is best equipped to ensure that the maintenance is regular and consistent. MCWD will be managing vegetation at a total of 23 sites throughout the District under contracts executed in 2016 and 2017, agreements with Great River Greening, and this proposed contract. This contract initiates ongoing vegetation maintenance at 4 sites where construction warranty maintenance has ended (Long Lake Creek Wetland), where grant-funded management is limited in scope and additional management is needed (Six Mile Marsh Prairie), and where new maintenance obligations are being initiated (Laketown Wetland and Methodist Hospital Wetland). With this contract framework, all contracts for vegetation management at the 23 sites will expire at the end of 2018 and new contracts will be entered in 2019.

Long-term maintenance is needed to preserve investments at these four sites. Therefore, the District has solicited quotes for vegetation management from four contractors and has received three quotes for a scope of work providing for management of these four sites for a period of one year. Staff has considered seeking quotes for management of each of these sites individually, but administrative savings were found by grouping the management of these four sites under one contract. The quotes received are listed below:

Staff recommends awarding the Laketown Wetland, Six Mile Marsh Prairie, Long Lake Creek Wetland, and Methodist Hospital Wetland contract for vegetation maintenance to Applied Ecological Services in the amount not-to-exceed \$29,365 and establish a not-to-exceed budget of \$32,302.

BE IT FURTHER RESOLVED that the Board establishes a project maintenance budget in the not-to-exceed amount of \$32,302 and authorizes the District Administrator, in his judgement, to authorize change orders obligating the District up to that amount.
