PURPOSE or ACTION REQUESTED:

A Request for Qualifications (RFQ) that described the role of counsel and the scope of services was prepared and posted in the newspaper, on the MCWD Website and mailed as requested.

Smith Partners was one of two firms to respond to the RFQ; the Board was provided with all documents submitted from both firms for their review; based on the comparison of their qualifications, staff recommends continuing with Smith Partners for the District's legal counsel.
