PURPOSE or ACTION REQUESTED:

Authorization to award a contract to the lowest qualified bidder for stormwater pond maintenance at Gleason North Ponds 2 and 3 in Plymouth.

SUMMARY:

In April 2015, field surveys were conducted to determine sediment accumulation at 10 regional stormwater ponds. The surveys determined that sediment accumulation was 57% in the Gleason Lake North 2 pond and 68% in the Gleason Lake North 3 pond. Maintenance of these ponds was recommended to provide for the ponds' proper function.

Staff has budgeted \$168,200 for pond maintenance in the 2016 Workplan. This budget was based on the engineer-estimated costs to maintain the Gleason Ponds 2 and 3 during the winter of 2015-16 and estimated cost to conduct next year's (2016) pond sediment surveys.

The bid opening for the pond maintenance project took place at the District office on Friday, October 30, 2015. The estimated budget for this work was \$64,286.25. Bids were received from six contractors and are listed in the table below. Sunram Construction submitted the lowest qualified bid.

WHEREAS,	the 2016 budget and work plan were based on the Engineers construction estimate; and NOW, THEREFORE, BE IT RESOLVED that the Minnehaha Creek Watershed District Board of Managers; hereby awards the contract for construction to Sunram Construction, Inc., for a not-to-exceed amount of \$49,570, and authorizes the District Administrator to execute a construction contract for the stormwater pond maintenance project and to return and otherwise administer bid bonds in accordance with the terms of the request for bids; and
WHEREAS,	at the MCWD Board Workshop dated November 12, 2015, it was moved by Manager Rogness, seconded by Manager Calkins and passed 6-0 that this resolution be forwarded to the next Board Meeting for final action.
BE IT FUTHE	R RESOLVED, that the MCWD Board of Managers establishes a project construction budget in the not-to-exceed amount of \$49,570 and authorizes the District Administrator, in his judgment and on the recommendation of the construction manager, to authorize change orders obligating the District up to that amount; and
