**Summary:**

The 2017 Strategic Alignment Plan prioritized investment in IT to more effectively implement high impact capital projects and influence policy through deep insights of natural and built environments. These insights are derived from innovative data analysis, possible only through a system of closely connected technology solutions.

Born from this 2017 directive, the District developed a Strategic IT Plan, and is currently executing that plan through the evaluation, selection, implementation, and build-out of technology solutions. The Strategic IT Plan seeks to advance the District’s ability to leverage data in order to drive decision making. This is accomplished through the elimination of silos, and ensuring technology solutions are closely connected. As a result, the District will efficiently capture information that passes through the organization, analyze that information to derive deeper understanding, and to enhance interactions with partners and the public.

In 2019 and 2020, as part of this initiative, the Board approved the purchase and acquisition of a new platform for GIS, and a module to enhance the accessibility of the District’s existing water quality database, WISKI.

Annual costs for these platforms include user license renewals, which are required to leverage various levels of functionality within the software. User licenses provide data access and modification rights, advanced toolsets for analysis, and system administration tools.

Annual costs also includes maintenance, which provides benefits that allow the District to maintain its technology investments by keeping software updated, secure and stable. These benefits include access to new features, technical support and new training materials.

Geographic Information Systems (GIS)

In 2019, the District acquired ESRI ArcGIS software to harness, analyze and share spatial data. GIS serves as the central hub through which spatial data is accessed across the organization. GIS provides tools for advanced data analysis to increase understanding of the natural and built environments. GIS is a platform that enhances communication with external partners and the public.

MCWD’s current GIS maintenance and licenses include:

- *ArcGIS Online* – 2 user licenses to share data, maps and applications with the public securely
- *ArcGIS Desktop* – 2 licenses, basic and advanced – software utilized for spatial data creation, advanced analysis, map output. The Basic license provides functionality suitable for most GIS tasks, while the advanced license provides functionality need to administer the platform and central spatial database.
- *ArcGIS 3D Analyst* – toolset for ArcGIS Desktop providing functionality to leverage and analyze 3D spatial data, such as LiDAR.
- *ArcGIS Spatial Analyst* – toolset for ArcGIS Desktop providing functionality to leverage continuous data, such as digital elevation models.
- *ArcGIS Enterprise* – the core platform, including the centralized spatial database, giving users access to GIS data, maps and applications through a web browser.
- *ArcGIS Enterprise Creator* – 3 user licenses providing tools, applications and functionality needed to create, share and deploy maps and applications.
- *ArcGIS Enterprise Field Worker* – 10 user licenses providing tools, applications and functionality needed to collect and edit data in the field.

2022 GIS maintenance and license costs have increased approximately 0.4% (\$55.00) compared to 2021. The quote for 2022 maintenance and license renewal for ArcGIS Enterprise, ArcGIS Desktop and ArcGIS Online is summarized in the table below:

## WISKI

In 2015, MCWD invested in Kisters WISKI database system to store Research and Monitoring's field collected data. The District also invested in a number of modules that extend the functionality of WISKI, such as KiECO, which provides tools for storing biological data. In 2020, as part of the strategic IT update, the District acquired the KiWIS module that provides wider access to data stored in WISKI for use in other platforms and applications, such as the website or GIS.

MCWD's current Kisters WISKI database and module maintenance and licenses include:

- *WISKI Annual Maintenance* - the core platform that supports the database
- *WISKI User Licenses* - 4 user licenses for the Kisters WISKI database platform
- *KiWQM Annual Maintenance* - water quality module, supports the water quality database
- *KiECO Annual Maintenance* - biological module, supports the water quality database
- *KiWIS Annual Maintenance* - database connection module, supports GIS integration of R&M's water quality, hydrology, and biology data

2022 WISKI maintenance and license costs have increased approximately 3% (\$437.00) compared to 2021. The quote for 2022 maintenance and license renewal for WISKI, KiWQM, KiECO and KiWIS is summarized in the table below:

WHEREAS, a critical component in operationalizing this strategy is the effective deployment of technology; and

WHEREAS, in pursuit of investing in technology to enhance the District’s work, a detailed review and selection of GIS software licenses, and WISKI software licenses was conducted; and

WHEREAS, on October 24, 2019 the Board approved the purchase of ArcGIS Enterprise and Desktop software; and

WHEREAS, on April 9, 2020 the Board approved the renewal of existing WISKI and GIS software licenses and maintenance, and the purchase of an additional module to extend the functionality of the District’s WISKI database; and

WHEREAS, license and maintenance renewal is critical to sustain the District’s technology investments by extending benefits like technical support, training, and access to updated software; and

WHEREAS, a quote for GIS license renewal and maintenance was obtained from Environmental Systems Research Institute (ESRI); and

WHEREAS, the cost of GIS license renewal and maintenance through April 27, 2023 is \$15,717.00; and

WHEREAS, a quote for WISKI license renewal and maintenance was obtained from Kisters North America; and

WHEREAS, the cost of WISKI license renewal and maintenance through May 1, 2023 is \$14,957.00;

NOW, THEREFORE, BE IT RESOLVED that the Minnehaha Creek Watershed District Board of Managers hereby authorizes the renewal of GIS software maintenance and licenses for an amount of \$15,717.00.

AND, NOW THEREFORE, BE FURTHER RESOLVED that the Minnehaha Creek Watershed District Board of Managers hereby authorizes the renewal of WISKI software maintenance and licenses for an amount of \$14,957.00.
