Authorize District Administrator to execute agreement with Terramark to develop a continuing education course for realtors.

June 5, 2014 Operations and Programs Committee reviewed the 2015 Education and Communications workplans, which included funding for developing the continuing education course for realtors

September 11, 2014 MCWD Board of Managers approved the 2015 Proposed Budget, which included funding for the realtors course in the Education and Communications workplans.

SUMMARY:

To support the District's Balanced Urban Ecology policy framework, which is the foundation for the <u>District's District's projects</u> and programs, MCWD's Education and Communications programs are proposing a new outreach tool to reach landowners. An accredited continuing education course offered to realtors will give the District an opportunity to educate this audience about the importance of protecting water quality, the role of watershed districts and the resources they can offer property owners.

By engaging with these audiences, it is hoped property owners will develop a heightened awareness of water quality issues, gain a greater understanding of the District and its programs and, as a result, will engage with the District early on as they pursue building and landscaping projects.

A memo outlining this proposal was first presented to the MCWD Operations and Programs Committee on January 2, 2014. Funding for the initiative was included in the 2015 Education and Communications workplans which were reviewed by the MCWD Operations and Programs Committee on June 5, 2014, and included in the District's 2015 proposed budget which the MCWD Board of Managers approved on September 11, 2014.

Pending approval by the MCWD Board of Managers, this course would be developed between April and August of 2015 and submitted to the Minnesota Department of Commerce for approval in the fall of 2015. Pending approval by the state, the course would be offered as an accredited continuing education course by the Minneapolis Area Association of Realtors in the spring of 2016.
