## **Summary:**

By statute, MCWD is obligated to annually appoint members to its Citizen Advisory Committee. The CAC's primary statutory role is advising the MCWD Board of Managers on issues pertinent to the functions and purpose of the watershed district.

At the November 5<sup>th</sup>, 2020 Board of Managers meeting, staff provided a briefing on the CAC's current strategic position within MCWD and plans to evaluate the committee's workflow, meeting structure, and strategic orientation. With this pending assessment, and the challenges of the remote work meeting environment, staff recommended current CAC members are reappointed and that the single vacant seat not be filled in 2021.
