Summary:

Pursuant to Minnesota Statute 103B.227 a watershed district is required to solicit interest proposals for professional services, including audit services, at least every two years. Pursuant to Resolution 20-057 the District solicited proposals for audit services, including posting on the District website and via a notice in the approved District newspaper, the Star Tribune.

The District received responses from three vendors: Clifton Larson Allen LLP, Redpath and Company, and WIPFLI LLP. District staff, along with the District's contracted accounting staff at AEM Financial Solutions, reviewed proposals for information such as, but not limited to the vendor's experience and understanding of watershed districts, overall experience working with governmental agencies, ability to meet our audit deadlines and overall cost. Relevant information is included below for your review.
