## **PURPOSE or ACTION REQUESTED:**

Name the 2015 depository for MCWD financial assurances

#### SUMMARY:

The MCWD Bylaws direct the Board of Managers to annually name its depository for financial assurance instruments. District legal counsel has maintained bonds and letters of credit submitted to the MCWD to secure permit performance in a secure cabinet and tracked associated information (permit number, issuer, amount of assurance, expiration date, etc.) for many years. The tracking spreadsheet is monthly transmitted to staff. Staff has held bonds and letters of credit submitted to the MCWD to secure performance and payment on MCWD projects at the District offices; from here on, financial assurances for present and future projects will be held at Smith Partners.

#### Staff Recommendation:

Maintain Smith Partners as depository of MCWD financial assurance instruments.
