Re: Item 4.2 Meadowbrook Golf Course Update

Purpose:

To provide an update to the Board of Managers on the status of the Meadowbrook Golf Course project and recent planning by MCWD and Minneapolis Park and Recreation Board staff.

Background:

Following historic flooding of Meadowbrook Golf Course in 2014, the Minnehaha Creek Watershed District (MCWD) and the Minneapolis Park and Recreation Board (MPRB) initiated a collaborative effort to restore Meadowbrook Golf Course, remeander Minnehaha Creek within the course, and construct a public trail along the eastern portion of the property, which would connect the trail system to the north of Excelsior Boulevard to City of Edina trails to the south of Meadowbrook Lake. This initial planning work was halted in 2016 when MPRB determined that adequate funding was not available to complete the proposed course restoration. MCWD maintained its interest in following through on the creek remeander and restoration and re-engaged MPRB in the fall of 2017.

MCWD and MPRB have reinitiated planning efforts and are developing a concept plan that includes a remeander of Minnehaha Creek within a widened stream buffer, the realignment of golf holes 5, 6, and 7 to be better integrated into a more naturalized creek flow pattern, and the construction of a public trail that will connect trails at the MCWD Preserve and Methodist Hospital's boardwalk system to City of Edina trails in Todd Park to the south.

Natural resource goals of this project include slowing peak stream flows through a remeandered stream channel reducing erosion and downstream sedimentation, improving in-stream and riparian habitat, increasing safe public access that utilizes the stream corridor but is separate from golf play, and considering options for restoration in additional areas of the course.

Golf goals for the project include providing for a better alignment of these golf holes, integrating the alignment of play with the improved natural features, ensuring that this interaction provides for safety and adequate sightlines, maintaining minimum yardages, providing for public trail connections, and identifying areas within the project site and the course as a whole that can be converted to support pollinator species while improving the overall aesthetic quality.

MCWD and MPRB staff have been working on preliminary concepts that achieve these goals.

At the April 26, 2018 PPC Meeting staff will provide an overview of the current status of preliminary partnership planning with the Minneapolis Park and Recreation Board and discuss next steps.

Next Steps:

The development of a preliminary concept plan and a draft cost estimate is necessary to support the development a project partnership agreement between MCWD and the MPRB.

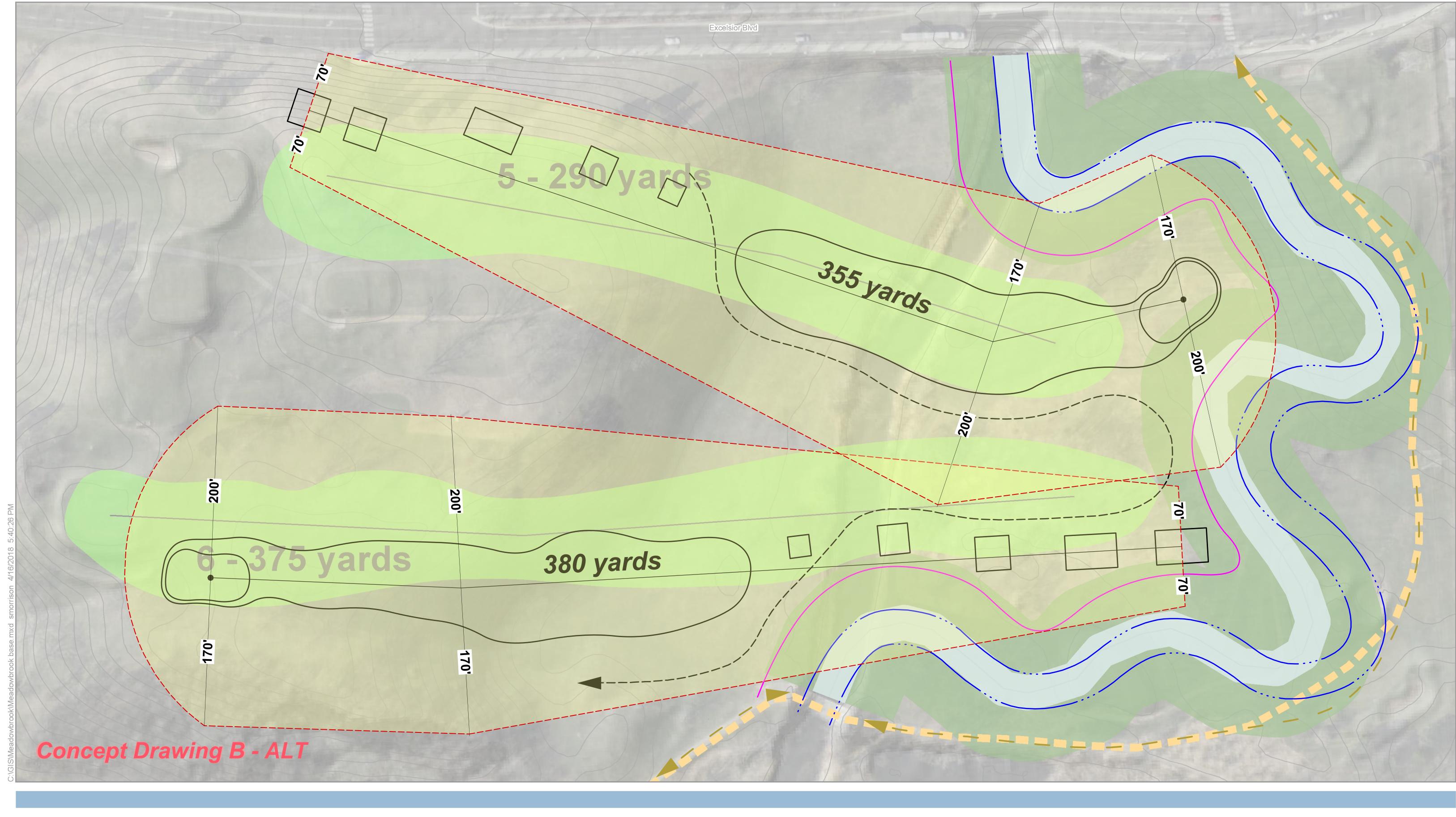

Attachment 1: Preliminary Concept Plan

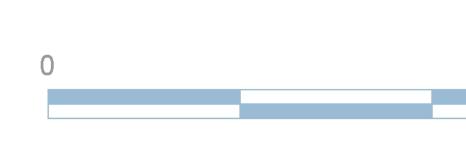
